## ***IMPORTANT NOTICE FROM THE NEW YORK STATE DEPARTMENT OF TRANSPORTATION***

### **THE SINGLE STATE REGISTRATION SYSTEM (SSRS) WILL BE REPLACED WITH A NEW UNIFIED CARRIER REGISTRATION (UCR) PROGRAM**

- **So, SSRS is gone and there's going to be a new UCR Program. What does it mean to me?**
  - It means you can continue to operate throughout the U.S. When the new UCR program is up and running you'll need to register with a UCR base state, for example New York. We are hopeful the new program will be ready sometime in the spring or early summer of 2007.
- **Will my drivers get tickets for not having a 2007 SSRS receipt?**
  - They certainly shouldn't. There is no 2007 SSRS receipt for your drivers to carry. If you like, carry a copy of this notice in your trucks or buses in case a question comes up about SSRS or UCR.
- **Tell me about this new UCR Program.**
  - It is a new streamlined national registration program which applies to both for-hire and private motor carriers that operate commercial vehicles in interstate commerce. It also applies to leasing companies, freight forwarders and brokers.
- **Will there still be a fee under UCR and how will it be calculated?**
  - The fee levels will be based on the number of commercial vehicles you operate. This differs from the SSRS which was based on the number of trucks or buses you operated and in what states you traveled. The proceeds from the UCR Program are to be used for motor carrier safety initiatives.
- **Will the UCR cost more than SSRS?**
  - The UCR fees have not yet been determined; however, the states will collect the same amount of money as in past years under the SSRS.
- **With the new UCR Program not ready for prime time what do I need to do?**
  - Absolutely nothing! When the new UCR Program is ready to roll out, we will mail you an application with instructions just like we've done in the past. So, enjoy the rest of your holiday season!
